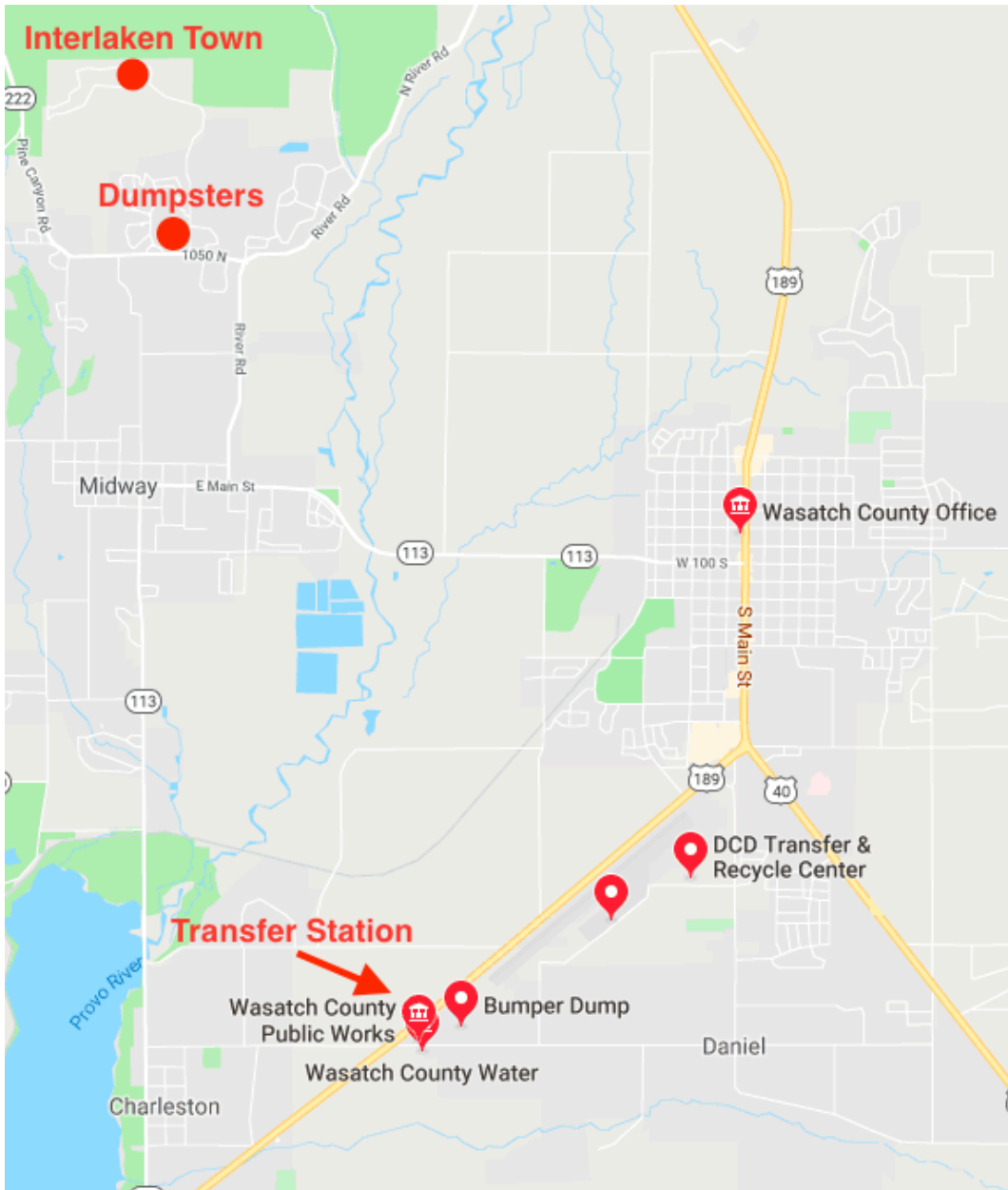


Wasatch County Solid Waste

Interlaken Town does NOT provide garbage collection services for homeowners at their lots. Interlaken residents haul their household garbage to dumpsters located in the parking lot next to the baseball diamond at the Midway Valais Park, at the foot of Interlaken Drive. These dumpsters are to be used for household waste only, and only by current residents of Interlaken Town. Please recycle your cardboard, paper, plastic, cans and other recyclable materials at a recycling center (see the link for Recycling on this webpage.) Do not use the dumpsters for large items, metal, yard waste, or construction debris. Please do not leave items on the ground outside the dumpsters. For those types of material, you should haul your waste to the transfer station located at 1891 West 3000 South, in Heber. This station is located just off highway 189 (Provo Canyon Road) at the Wasatch County Public Works site:

Billing for Wasatch County Solid Waste is on an annual basis, in the middle of the billing cycle. As part of the annual fee, the county provides lot owners with a punch pass valid for 3 trips to the transfer station during June of each year. These free trips are limited to one pickup sized load each trip and valid only during June of that year. Be sure to bring your bill (see below) with you to the transfer station to get these free trips. Contact Wasatch County Waste directly if you have any questions or concerns at 435-654-3223.

Wasatch County Solid Waste Disposal District and Bulky Waste Transfer Station are located at 1891 West 3000 South. Wasatch County Solid Waste Disposal District provided containers must be out to the curb or roadside by 7 a.m. on your collection day. County Code requires that the container be removed from the curb or roadside within 24 hours after your collection day. Excess or bulky items will need to be disposed of at the Bulky Waste Transfer Station.

Solid Waste District Office Hours are 8 a.m. to 5 p.m. Monday thru Friday

Bulky Waste Transfer Station hours are 8 a.m. to 5 p.m. Monday thru Saturday.

Wasatch County Bulky Waste Transfer Station does not accept dirt, rocks, concrete, asphalt or large tree trunks. If you have questions about the use of the Bulky Waste Transfer Station, call (435) 657-3287.
